**Essential Qualifications:**

- (i) Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's level in Law from an Indian University or an equivalent degree from an accredited foreign university;
- (ii) Besides fulfilling the above qualification, candidates must have cleared the National Eligibility Test (NET) conducted by the UGC/CSIR or similar test accredited by the UGC like SLET/SET for those with Ph.D. degree.
- (ii) Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates, who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. degree) Regulations, 2009 shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor/Guest Faculty.
- (iv) NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

Further, the award of degrees to candidates registered for the M.Phil/Ph. D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/By Laws/Regulations of the Institution awarding the degrees and the Ph. D. candidates shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for requirement and appointment of Assistant Professor or equivalent positions in University/Colleges/Institutions subject to the fulfillment of the conditions:

- (a) Ph. D. degree of the candidate awarded in regular mode only.
  - (b) Evaluation of the Ph. D. thesis by at least two external examiners
  - (c) Candidates had published two research papers out of which at least one in a refereed journal from out of his/her Ph.D. work.
  - (d) The candidates had presented two papers in seminars/conferences from out his/her Ph. D. work.
  - (e) Open Ph. D. Viva-voce of the candidate had been conducted.
- (a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean (Academic Affairs/Dean (University Instructions).
